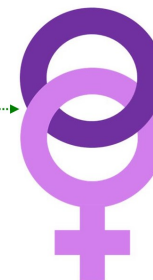

§ 95 (1a) und § 107 (3 Z1)AußStrG

Since 2013, parents are obliged by law to seek counselling before divorcing by mutual consent to guarantee the understanding of the divorce's legal impact on their underage children. Mediated counselling can also be mandatory by court order to negotiate matters of custody and contact. **FIBEL** offers such mediated counselling.
